6 7 8	RELATING TO THE RECOGNITION OF NEIGHBORHOOD ASSOCIATIONS; REPEAL OF ORDINANCE NO. 93-257
9 10	The City of Keizer ordains as follows:
11	Section 1. <u>PURPOSE</u> . This Ordinance is intended to recognize that
12	neighborhood associations are an important part of the involvement and volunteerism of
13	the residents of the community in Keizer city government. Active neighborhood
14	associations enhance the City's resident involvement program and provide an important
15	two way channel for information relative to the activities of the City. This Ordinance is
16	intended to provide a framework for establishment and recognition of neighborhood
17	associations and to acknowledge such associations as legitimate representatives of the
18	residents and issues within their boundaries.
19	Section 2. NEIGHBORHOOD ASSOCIATIONS. A neighborhood association
20	is any group of people organized within a geographical area for the purpose of studying
21	and acting on issues affecting neighborhood and city-wide livability and government
22	operations, and that also actively solicits broad involvement by all residents within the
23	association's boundary. A recognized neighborhood association is one that has been
24	found by the City Council to satisfy the standards of this Ordinance.

2	neighborhoo	d association as described in Section 4 and 5 below. For a recognized
3	neighborhoo	d association the City will do the following, at a minimum:
4	(a)	Email the association requests for comments and public hearing notices for
5	all planning,	zoning, and subdivision activities within its boundaries, unless specifically
6	required by	law to mail.
7	(b)	Email the association notices of other City issues that may result in action
8	being taken i	impacting property or the residents within the association boundary, unless
9	specifically	required by law to mail.
10	(c)	Email the association agendas for all City commissions, boards, and City
11	Council mee	etings.
12	(d)	Solicit the input of the association at early stages of major decision
13	making, sucl	h as annual budget preparation and amendments to the Comprehensive Plan.
14	(e)	Recognize the association as having standing in land use cases within its
15	boundaries o	or within adjacent areas where there is a direct impact when input from the
16	affected neigh	ghborhood association is received by the City ahead of or during any de
17	novo hearin	g on the matter.
18	(f)	Provide assistance in publicizing the activities of the association through
19	press release	es, city publications, and other media as resources allow.

Section 3. RECOGNITION. The City Council may officially recognize a

1	(g) If a neighborhood association applies for and obtains the least costly local
2	post office box option, the City will reimburse them for that cost out of the amount
3	budgeted for the neighborhood association.
4	(h) If budgeted funds are available, a neighborhood association can seek
5	reimbursement from the City funds dedicated to them in accordance with the
6	neighborhood association reimbursement policy established by the Council and provided
7	by the finance department.
8	Section 4. PROCESS FOR RECOGNITION. A neighborhood association may
9	petition the City Council for official recognition. If the Council finds that the standards
10	outlined below are met, the association may be recognized by resolution.
11	Section 5. STANDARDS FOR RECOGNITION. The following standards must
12	be met by a neighborhood association seeking and maintaining recognition:
13	(a) <u>Bylaws.</u> The association shall adopt bylaws that contain the following
14	provisions at a minimum:
15	1. Any person who resides, operates a business, or owns property
16	within the boundary shall be a member with the right to participate and vote.
17	2. Membership or participation shall not be limited based on any
18	protected class under Oregon or federal law.
19	3. There shall be no dues, but voluntary contributions may be
20	solicited.
21	

L	4. The association shall hold an annual general meeting, with the time,
2	date, and place of the meeting widely publicized throughout the neighborhood
3	prior to the meeting. Other general meetings may be held as desired.

- 5. Regular meetings of the association board shall be held at a publicized date, time, and place. All association board meetings shall be open to the public. All members present may vote on issues with the results recorded separately from votes of the association board.
- 6. Minutes shall be taken of all board and general meetings, with the minutes made available to any person so requesting. A copy of the minutes shall be filed with the City Recorder.
- 7. The association shall have a Board of Directors with a president, vice-president, and secretary who shall be elected annually by those present at the annual meeting. The association may establish additional elected positions on the board. The board roster including names, addresses, and email addresses shall be filed with the City Recorder. The association shall provide an address to the City for mailing purposes. The Board of Directors shall fill any officer position vacancies by the third meeting following the vacancy to meet the required three board positions. For additional vacancies, the bylaws must address what is considered timely in filling additional board positions above the minimum three officers.

1	8. A copy of the bylaws shall be reviewed by the City Council upon
2	initial adoption and any amendments made by the neighborhood association. The
3	Council shall have the final determination of a neighborhood association's
4	bylaws and any amendments thereto.
5	9. A copy of the bylaws shall be filed with the City recorder and
6	maintained and updated to reflect amendments by the neighborhood association.
7	(b) Boundary. The association shall adopt by motion a fixed geographic
8	boundary meeting the following general guidelines:
9	1. The neighborhood should generally encompass at least 300
10	dwelling units or smaller clearly defined areas.
11	2. The neighborhood should generally encompass a logical geographic
12	and social area with generally rectangular boundaries and without any
13	gerrymandering.
14	3. The neighborhood should generally focus on a single elementary
15	school attendance area.
16	4. Neighborhood boundaries should generally follow natural or
17	manmade barriers such as creeks and arterial streets. When a boundary must
18	follow a local street, it should follow rear property lines rather than divide the
19	neighborhood between houses facing each other.
20	5. The boundary should encompass adjacent vacant or
21	underdeveloped land.

1	6. The boundary should extend to the city limits.
2	7. The boundary should leave no isolated areas or pockets not
3	included in another neighborhood association's boundary.
4	8. The Council shall have the final determination of a neighborhood's
5	boundary and is not necessarily bound to the above guidelines. This
6	determination shall be reflected in the resolution of recognition.
7	c. <u>Responsibilities.</u> The following responsibilities must be assumed and
8	carried out by a neighborhood association:
9	1. The association must strive to accurately represent the best interest
10	of its members when expressing neighborhood opinion, recommendations, and
11	concerns before any public body.
12	2. The association solicits the participation or input of all members
13	through newsletters, media coverage, personal contact, flyer distribution, and
14	social media. Associations must maintain an active and up-to-date online
15	presence that adheres to City Council social media standards. All official
16	webpages shall maintain at least three administrators having access to the site and
17	its contents.
18	3. The association must actively engage with City government
19	through participation, input, and recommendations on issues brought to it by the
20	City, or initiated by the neighborhood itself.
21	

1	4. The association must hold regular board and general meetings, with
2	timely, appropriate notification to members. The association must maintain at
3	least a minimum attendance of three members at regular, general meetings.
4	5. The association must strive to improve the livability of the
5	neighborhood and of the community as a whole through education, activities,
6	projects, and participation.
7	6. The association must attend an annual joint session with the City
8	Council on a date set by the City.
9	Section 6. MAINTAINING RECOGNITION - ANNUAL REPORT. A
10	recognized neighborhood association shall make an annual report to the City Council at
11.	a Council meeting between March 1 and April 30 each year. This report may be in
12	writing or presented orally. The report shall include at least the following elements:
13	(a) A record of all meetings with attendance noted.
14	(b) A summary of all issues dealt with by the association.
15	(c) A summary of special association activities outside regular meetings.
16	(d) A report of all efforts to solicit the participation and input of all members
17	of the association.
18	(e) An analysis of the association's success in meeting its responsibilities as
19	outlined above.
20	(f) An affirmation that they are in compliance with the neighborhood's
21	bylaws at the time of the annual report.

1	Section 7. MAINTAINING RECOGNITION - COUNCIL ACTION. If the
2	Council finds the association has continued to meet the requirements for recognition as
3	outlined in Section 5, it can, by motion, extend recognition for an additional year.
4	Section 8. TERMINATING RECOGNITION. At any time, the Council may
5	consider an association's alleged failure to meet the requirements for recognition. If the
6	Council finds the association has not continued to meet the requirements for recognition
7	as outlined in Section 5, the Council may, by resolution, revoke recognition.
8	Section 9. REPEAL OF ORDINANCE NO. 93-257. Ordinance No. 93-257
9	(Relating to the Recognition of Neighborhood Associations) is hereby repealed in its
10	entirety.
11	Section 10. <u>EFFECTIVE DATE.</u> This Ordinance shall take effect thirty (30)
12	days after its passage.
